I have heard already of one potential and it would be great to see more. Deadline for 2024 submissions is October 31, 2023. 2025 deadline is March 1, 2024. 2026 deadline is March 1, 2025.

• Directorships

Outstanding departments are: Office of the Master Petty Chief (MCPO), Director of Accessibility (DoA) and the Director of STARFLEET Perks (DoSP). These posts are on the VR site and we are compiling the information and updating the descriptions. As of this writing the interview process has started For the DoA. The other two continue to remain open.

 Currently, the VCS and I are working on a style guide for Organization, Region and Chapter use of the SFI Branding. We hope you have liked seeing some of the new elements we have been showing over the last few months. We have completed production on the 50th Challenge coin and any day now the Quartermaster will have them up for sale along with the new SFI Flag. The new SFI Combadges are complete and will also go up for sale. We have begun the process of the inserts. There are two that go with the badge. First is just a curve shape and the other is a delta. We have the Diversity delta and curve designed. The 50th curve is also complete. These three will go in for quote and be added to the QM site as presale items very soon. #### SFMC FORCECOM

- In the past two months, FORCECOM has done many different things and stuff, including help with the SFMC portion of the VIC in AUG, and other points below. You may choose what to report onward.
- Since taking over FORCECOM, I allowed my last post, DCOFORCECOM-Operations, to lay fallow while I figured out what it was I was taking over. My goals have been to stabilize FORCECOM, keep it on an even keel by naming capable officers to fill the ranks of Brigade OICs, as well as to keep the Awards team on task, all with the purpose of handing off a functioning department to whoever replaces me. I would rate my success of the last five months at ""mixed"". The fact is, there is always something else that needs to be fixed, so it may be that I will be here a lot longer than I thought. My goal then becomes to ensure that I do not become part of any problems.

- The brigade posts have been filled, and with Eric Johansson standing down as Awards Honcho (and taking up post as ""Aide-de-Camp"" - consultant so we can continue to make use of his experience and expertise), both DCO posts are open, and have been posted to STARFLEET Volunteer Resources accordingly. I allowed for three weeks to accept applications, rather than the usual two, to try to fling the nets wide (and so people could take academy courses, because I wanted to ensure that anyone putting in had some kind of grounding in what SFMC is all about, prior to any interviews). As with the Brigade OIC posts, I will interview all comers, but as yet I have not decided if I will go with the same guestions for each, as I did before.
- INFOCOM needs info and is way behind. Personal life matters and hectic schedule of COINFOCOM to blame."

"There have been two situations to note over the past month.

First (1st) Brigade has had an influx of new Units form with another unit soon to form. FORCECOM has appointed Dona Rozelle to the position due to her already working within the role. Though some grumblings within the brigade have arisen from the appointment, FORCECOM and the General Staff is in support of the appointment and will help when/if needed.

A new BOIC has been appointed by FORCECOM to the Thirteen (13th) Brigade. Though the beginning of the relationship between the BOIC and the RC staff was tumultuous, with the help of FORCECOM and other members of the General Staff, it is hoped that everyone will be able to start anew and begin to lay the ground work towards success within the Brigade.

The General Staff will be watching these two situations as they play out over the next few months and lend support and guidance to each as needed."

The premiere of *STARFLEET News Now* was on Sept. 24, and comments on the production have been very positive. Being the first broadcast from the Comms Dept., there are a few things we will work to smooth out for the next one. Producers CMDR Bradley O'Connor and CAPT Ryan O'Connor did an excellent job of "creating" this "next generation" show, aided by Director Ken Kopacki, the hosts and guests. We have added a West Coast Producer, ENS Fred Copeland of the USS Golden Gate, who was able to produce a segment on short notice when time was getting close to broadcast and it had been difficult to schedule that segment with the primary Producers. The flexibility of having Producers on both US coasts will be useful going forward. There have been 468 views of SNN on YouTube so far. We know there were a number of people watching via Facebook too, but it's harder to get a number there since we only know who's watching if they make a comment. The next broadcast is scheduled for December 3 and will be "The Holidays Show."

Preparation of *The Communique*' (CQ) for its October 1 release was very busy in September. We've seen an increase in the number of chapter- generated articles submitted, which of course we like very much. Regular features such as the photo contest, con reports and schedule, Trek-inspired technology, and celebrity interviews have had very good feedback from readers. Following the CQ's release, CQ Editor Justin Hunt will be working with the Accessibility Committee for a trial-run of an edition in a format accessible to members that have special needs. This trial-run will be a "feasibility study" to give the committee a chance to see how long it takes and how much work is involved.

Social Media team members try hard to keep up with all requests and postings, but it is our desire to recruit a couple more team members to help with the current and potential future workloads for Facebook and Discord. The Facebook group "STARFLEET Communique' Newsroom" has been shut down and all members removed. It was too duplicative of what was on the Members Only and Business Only groups and we felt it no longer served a distinct purpose on its own.

The STARFLEET Pinterest group continues to see growth in its usage with an increase of 19% from the previous month's audience. The location of the audience has seen a shift as well. In September, the audience in the U.S. made up 23.9%, but the audience from outside the U.S. made up 49.7%. No explanation at this time for why this occurred. It might be just a one month anomaly, but it could indicate an increase in global interest in the site. The coming months' data will be telling.

I was in sickbay for much of the month, but there was no interruption in any Comms services. The Deputy Comms Chief and other members of the staff did a great job of filling in for me and keeping everything going smoothly while I recuperated. I can't thank them enough.

#### SFA NEWS

From the STARFLEET Academy Commandant:

September topped August in the number of courses taken overall, with over 2460 courses completed. However, we did have slightly fewer students, with only 177 individuals taking at least one course in the month. Some of the traffic this month was thanks to another challenge, this time from the Region One RDC of Operations, who offered the Captains of Starfleet Challenge. Originally only for R1 members, this was quickly opened to all of Fleet, and the challenge ended with 44 participants from 10 different regions and 29 different chapters. Those students took 140 courses. This is the kind of participation we like to see!

We still have one institute with missing grades, and that is the Institute of Space Studies. I appreciate the continued patience of students who may be missing grades from that institute. If you are still missing grades in any OTHER institute, please start by contacting the Director for the college, and they can start an investigation into the missing grade(s). Please be aware that you MIGHT be asked for certificate or other form of proof, but hopefully we will be able to find it in our records.

Participation in SFA (and SFMCA) is up, and that also means more Boothbys! Our Awards Program Director is still working on getting the backlog cleared from when the program had to be paused, but he is making progress, and I can assure you that anyone who is due a Boothby (either from past work or current) will get them as soon as possible.

Students sometimes ask me "what if I don't agree with my grade"? When you take a course, if you believe that you are not given credit for an answer that should be considered correct, your first stop is to contact the Director and politely raise a challenge. Please make sure to tell them which course, and include the text of the question and answers (not just the question number, as many of our exams have the questions shuffled), and the reason that you believe your answer is correct. Directors should answer you within a week, and let you know if they believe your challenge is valid. If your challenge is successful, your grade will be changed. However, if the Director denies your challenge and you still believe there is an error, you have the right to elevate your challenge to the Dean of the institute. If necessary, you may continue to elevate your challenge, going next to the Academic Coordinator, then to the Vice-Commandant, and then to me. In some cases, the CES may even get involved. If you believe there is a problem, please speak up ... it could be

be a programming error, or an error on the key. Additionally, if you see typos or similar errors in our materials, please bring those to the attention of the Director. We try to make sure we catch those before materials are released, but things do get past us from time to time.

If you have ever considered joining our staff, now is a good time. We have several openings for Assistant Directors, and there are some new colleges that are being created that will need Directors and Assistant Directors. We maintain a job listing for Assistant Directors at the <u>Volunteer Resources website</u> and when we have Director openings, those will be listed separately. The last few weeks have been incredibly busy in our department. In the wake of the Region 3 Summit presentation earlier this month, our team has been diligently working to enhance the capabilities of our database systems and improve the overall user experience. In addition to these technical advancements, we have also made important staff changes and launched various initiatives to optimize our processes.

#### Database

Following the presentation at the Region 3 Summit early in the month, the work that has been completed was deployed to the test server where select members who agreed to have their PII utilized were able to log in and see the work that was demoed. A number of bugs were identified through this effort and prioritized to be quickly fixed. In new development, two key features that were completed this month include password reset functionality and two factor authentication. Both of these efforts required integration with Mailgun to send automated emails to members, which will be crucial to ongoing development. Current application development work is focused around user registration and membership processing, which will require PayPal integration. Another ongoing effort is the creation of a deployment schedule and a CI/CD pipeline to automate deployments of new development on a bi-weekly basis. In addition, the form for PII consent for test users was rereleased, and the pool of test users increased to 30 members.

#### Routine Server Maintenance

Two of our servers were temporarily taken offline to facilitate routine maintenance conducted by Tony Knopes. The maintenance was executed successfully, and no issues or anomalies were identified during the process.

#### Staff Changes

We are pleased to announce the addition of two deputies to our team. Colonel Scott Sawyer will be assuming responsibility for the oversight of all our Web Technologies, while Rear Admiral Tony Knopes will take charge of our existing database and mail technologies. Both Tony and Scott are actively engaged in supervising the development of our new database project. We have expanded the role of our Chief of Staff, Fleet Captain Gregg Kleiner, to manage Jira ticket assignment and the supervision of our written materials.

#### EC Department Process Evaluations

Infoserv is in the process of evaluating different database processes as part of our efforts to establish the new database system. At present, our focus is directed towards the assessment of the functions of Ops within the chapter.

#### Quartermaster Website

The eagerly anticipated revitalization of the Quartermaster site has been successfully completed and officially transferred to the new Quartermaster for utilization by our membership. During testing, a purchase and payment transaction was executed seamlessly, with only one minor reported issue with a specific email address not being accepted by PayPal with a comcast.net email. We are looking into that issue. We extend our thanks to Chris Poole and Mark Anderson for their invaluable support and contributions in successfully bringing this project to fruition.

#### Current SFI Website

An email notification has been dispatched to the ECAB, outlining the procedure for submitting content for inclusion in the announcement section of the SFI website. Members interested in posting significant announcements are encouraged to reach out to their respective RCs.

We are actively working on reintroducing an events calendar to showcase virtual events accessible to all SFI members. If you have a special or recurring event open to all members, please don't hesitate to contact Greg Mortensen at <u>gmortensen infoserv@sfi.org</u>.

We are delighted to announce that SFI.org now offers support for multiple languages, accessible through the main menu.

#### SFI Email and Vanity Email Jobs

We are conducting an assessment of our existing vanity email addresses to verify their ongoing utility. It is within our capacity to generate vanity email addresses for auxiliaries, with a maximum allocation of 10 addresses per auxiliary. These email accounts will be subject to mailbox size restrictions. Requests for such email addresses can be made through our help desk services by auxiliary organization leads.

#### Weekly Team Meetings

Our team meets weekly, conducting two sessions to accommodate the diverse time zones of our team members. These meetings are a crucial platform for exchanging updates, addressing current issues and challenges, and strategizing upcoming work. In recognition of the interdependence between our departments, we have invited Membership Services to join any of our meetings, fostering collaboration and ensuring seamless coordination between our teams. These meetings will remain open to any other EC departments who wish to attend.

#### New InfoServ/DPO Processes Document

3. The 3 Orders of Samaritan in September were issued to Chapters. Pam stated that, last year, CS Parmley and Member Services Director Stimpson both approved awarding OOMs to Chapters. The Member's Hub page states the following: "The STARFLEET Orders of Merit Program is designed to recognize achievements of STARFLEET members at every level of the organization." A formal decision needs to be made regarding allowing chapters to be eligible or not.

Aloha Everyone,

There are five financial management-related updates for this month's Command Status Report from the CFO's Office:

#### (1) Current Financial Status:

As of close of business on September 30th, 2023, STARFLEET had a total bank balance of \$138,269 with two final \$1,000 scholarship payments still pending.

#### (2) First Quarter, FY2024 Performance:

Looking at our Fiscal Year 2024 first quarter (*July 1st thru September 30th*) performance, we collectively netted \$1,270 for the quarter, but had \$1,300 more in expenses for the month of July than we took in income-wise—due largely to expenses for the Virtual International Conference, Annual Awards, and software upgrades.

#### (3) Current 12-Month Financial Trends:

Looking at the past twelve consecutive months of financial activity (*September 1st, 2022 thru September 30th, 2023*), STARFLEET's balance sheet started with \$140,655 and ended this one-year period with a net balance of \$138,269. Deducting the two pending/still-processing \$1,000 scholarship payments, the adjusted actual bank balance is \$136,269. This figure accounts for a net operating loss of \$4,386 or ~3.1% for the past one-year period. During this same period, STARFLEET had more operating expenses going out than income coming in during four of the twelve months during this period (*October 2022, November 2022, March 2023, & July 2023*).

#### (4) Quartermaster Website Updates:

STARFLEET's new Quartermaster, RADM Christina Sievers, has been busy making updates to the existing Quartermaster website and is adding multiple new items ranging including new two-inch STARFLEET 50th challenge coins, new STARFLEET flags, and new STARFLEET Comm Badges.

#### (5) New CFO Logo:
