As we continue into 2024 the progress moving to strengthen STARFLEET into the future is going strong. We are working hard going forward for the benefit of SFI. Here is an update on where we are:

As of today, The Administration has completed or is still progressing on:

- Email server space migration has been completed. As a reminder SFI.org emails cannot be forwarded outwardly to other domains, especially if you are sending emails with more than 20 contacts. This has nothing to do with our servers but with the outside domains marking us as spam. Please be careful, one person can get us blocked for a random period of time.
- The SFI Combadges have arrived to the Quarter Master and are ready for sale. Get yours now. We have inserts and deltas in the works and they will be up for presale soon.
- The position of Director of Diversity has been refilled. Please welcome FCAPT Alicia Muhammad to the post. They are preparing for Pride in June so be on the lookout for more info on that.
- I am pleased that the membership passed the Admiralty Board update to section 3.4 of the Bylaws. With that acceptance, new verbiage will enter into the governing documents as passed by the AB outlining further clarity into the processes going forward.

More Work Ongoing:

- The administration continues to seek bids for the 2025 and 2026 International Conference in a VIC or Hybrid model. It is time to get together safely and see our friends and make new ones. If you wish to bid on this honor in whatever form, I encourage you to do it soon. The 2025 deadline is extended again to May 1, 2024. 2026 deadline is January 1, 2025. Be advised that any bid must take into account every member of Fleet. IC is meant for everyone not just for your local area.
- Ongoing creation of the new database platform estimated now for second quarter of 2024 and we are on track for this to happen with a hard launch at IC. The SNN productions will have more info on this in upcoming productions.
- 50th anniversary coins continue to be on sale now at the Quartermaster. New and updated SFI flags are also available from the QM. They have the updated logo and a new look. Get them now.
- Clean-up of the dataset will continue in April in collaboration with the Admiralty Board in preparation for transition to the new platform before IC.
- Directorships: Outstanding departments are: Heraldry Compliance Officer (HCO), and the Chief Cadet Officer (CCO). These posts are on the VR site and we are compiling the information. We are looking at the current applicants and will have these filled soon. Last chance on these final postings if you want to participate.
- Charity - Planetary Society: Planning and organizing how to collaborate with our charitable partners.
- Further updates and clarifications within the Membership Handbook to enhance the experience and protect our membership.
- We are in the process of enacting background checks ONLY for the leadership roles, of the Corporation, both domestic and international. Those members that seek high end corporate positions will be asked to pay for and run checks during their transition times to ensure that we don't have negative elements within our leadership. You know your own past and your fiscal responsibility. If you wish to keep that to yourself, as if your right, I would suggest you not put yourself in the spotlight. We are not seeking members that have made mistakes. We are however going to ensure going forward that the membership feel safe the leaders they have working hard to make an excellent Fan experience. Some will be just criminal and for those that deal with finances will have credit checks added to the process. This is being put forth in many Fandom groups and we should do the same to ensure our leaders are of a caliber and responsibility to lead. EC members, Staff and any Directorships dealing with minors will go into those processes. The general membership will not, ever be just checked, unless they are involved in an IG processed investigation requiring proof of repetitive issues or defense verification with full disclosure.

I look forward to the events coming thru August of 2024 hosted by the Chapters and the Regions of Fleet. Look out R10, 11, 13, and 17, I have my eyes on you to see you soon! FORCECOM - I am assigning Timko to 6th Brigade OIC on a temporary basis, complete with a temporary unit. 6th is about dead, but I'm hoping that this will give him a chance to get some experience running a brigade, which I believe is a necessary skill set for COFORCECOM, which he is striking for. I messaged Leo Rogers, the former 6BOIC before Pickett, and he was uninterested in taking the job again - he may even drop out as Unit OIC. When Pickett left as Brigade OIC, he disaffiliated with SFMC, thereby removing himself as Unit OIC there, and there is no DOIC to replace him, so this will be a project for Timko to attempt to fix. I also messaged Mike Urvand, the RCR6, outlining Pickett's leaving as well as Rogers' disinterest in the post, and asking if he had any recommendations, but he has yet to reply - been about a week. I'll message him to let him know about Timko here in a bit. Hopefully there is no butthurt, but we'll see.

I have gotten in contact with the RCR8, Owen Swart, to set up 8th Brigade as a host for any units that don't otherwise have a brigade available. I have a unit forming in Japan which will be the first customer. They will be the 666 MEU - "Demons", since 16th Brigade numbers are just direct assigned by COFORCECOM (according to the manual). There is a unit in 8th, the 360th... about dead, but it's on the books, so that and the 666th will serve as the two necessary to reopen the brigade under da rules. ADM Swart tells me that he doesn't believe that anyone in R8 will be available to run the brigade, so he asked me to check with this other unit. I have done so, and they are polling their members (and have been taking the SFDPP in preparation for

the unit creation, so there should be someone for this too). R8 has been advised that this all might be temporary, if say R16 actually gets a chapter or two operational through this, and thereby is able to open on their own account, so everybody is on the same page.

If 6th Brigade falls through, and there are any units left, I will reassign them to 8th. I am not confident there will be, but ya never know.

COForceCom and SGM has expressed being relived of duty, General Staff meeting first week of APR to discuss.

We created two new positions: Executive Deputy Director filled by CAPT Matthew Doucet, and CAPT Mary Demiter became the Deputy Director of Operations. - **Regional Liaisons:** The Regional Liaison Team expanded to include members from regions 1B, 1G, 3, 5, 7, 11, 12, 13, 17, and 20. - **SFPet Handbook Updates:** The STARFLEET Petfleet Handbook (Version 1.2) was updated on March 24th, 2024. It now includes new details about the Regional Liaison Program and reflects the recent staff changes, with new titles and job outlines for command staff members.
- **Academy Course Development:** Collaborating with STARFLEET Academy to publish a course featuring the updated handbook has progressed into the beta testing phase with hopes that it will be available to members within the next couple of months.

These efforts signify STARFLEET Petfleet's commitment to growth, organization, and providing valuable resources and support to its members.

We urgently need an Email Newsletter Editor to lead our quarterly newsletter. So far, we haven't received any applications for the position.

Additionally, we're seeking help from various regions to fill the positions of Regional Liaisons for those areas that are currently vacant.

We're also eager to collaborate with other Auxiliaries. At the recent DAS meeting, we discussed developing an SFPet Mascot for each Auxiliary, which we believe will be a valuable initiative.

I'm planning to meet with the Quartermaster to discuss future STARFLEET Petfleet products. To kickstart this, we're requesting seed funding from SFI to purchase our initial batch of products, such as SFPet crests and coins. I've already personally invested in buying some stickers for us to sell.

- We've conducted staff reviews and implemented staffing changes that we believe will significantly benefit our operations. Welcoming Matthew Doucet as our Executive Deputy Director is a great step forward for

project management and documentation. Assigning more responsibilities to Mary Demiter for SFPet Operations will also contribute to exciting program development for our members. We have a strong Membership team with Jessica and Jess who are really working together well. We're confident that our team is strong and ready for the challenges of 2024.

- Our Academy course is progressing rapidly and will soon be available to all our members.
- Our new website is making excellent progress. While we're currently focused on writing content for the pages, ensuring that the information is both engaging and accurate is crucial. We're particularly excited about our deep dive into SFPet's historical timeline, which has been a fascinating journey for both myself and our Executive Deputy Director, Matthew.

Overall, we're in a very positive position, and we're looking forward to a fantastic year ahead for SFPet and its members!

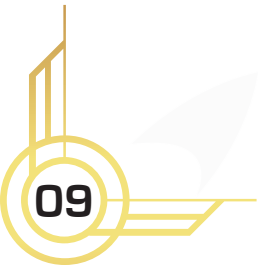

Greetings!

Here's the DTS report for SD12403:

(As a side note, this report will include some information from April, because of its significance and immediacy.)

DTS activity was fairly steady in March. One new vessel reservation request was received, for an established class. No vessels changed classes. No new classes were added. No new shuttlecraft were reserved. Two names were released following decommissioning or pre-shakedown group inactivity. On the departmental offices side, ASDB added a new staff member, but more recently, the director has had a death in the family and activity is temporarily paused. Progress was made, though, on both the Wayfinder-class starship proposal and near-finalization of the Ouroboros-class fightercraft, as well as further development of the "Starfleet Prototype" project. OTI responded to an inquiry regarding the Constitution (III)-class exploratory cruiser, and also continued work on updating the Trek Timeline developed by yours truly, and adding new material to reflect more recent series and the tie-in books to them. Work also progressed on the expansion of the Office's collection of vessel and station silhouettes for use in publications or for other graphical needs, and several new projects are also now in the conceptual stages. CAPT Gerhard Pretorius has resigned from the Office of Schematic Art, realizing that he is stretched too thin in terms of his 'FLEET workload and something had to give. His resignation has been accepted, though of course the door is open for his return, should he choose to do so, in the future. We continue to search for persons to take postings in OSA, as well.

Two new innovations are also in the works for DTS. BGR Liam Smith is working with me on, and taking point on the direct development of, a new full website for DTS. This will not only introduce the Department to curious visitors, and give a sense of what we do here at DTS, but it will also serve to host an archive of the many drawings, data files, and other Star Trek science, history, and tech info that DTS and its staff have developed over the years. Also, we are looking at creating a fourth sub-office within DTS! This one is going to be the Office of Research and Development, and will explore the category of items that are not starships. This office will explore auxiliary/embarked craft (e.g., shuttles and fighters) and equipment (e.g., shipboard hardware and landing party gear {computer terminals, scanners, left-handed spanners, communicators, tricorders, phasers, etc.}). Reports and tech docs on whatever we develop will be assembled and made available through the library/archive maintained by OTI (Office of Technical information). With these new steps forward, we hope to keep DTS developing and growing as an entity with which tech/science-oriented STARFLEET members can come and enjoy themselves.

While finalizing his ASDB report and several tasks on his plate, CAPT Scott Melrose had a death in the family. He has taken leave time to address this, and we are all supporting him where we can. He does report that he is preparing the final "Go" recommendation for Liam Smith's proposal for the Wayfinder-class fast exploratory cruiser, and work is nearly complete on the Ouroboros-class fightercraft. Also, a new member has joined the staff of the ASDB: CAPT Lourdes Bond.

Our thoughts remain with Scott and with the rest of Cheryl's family during this difficult and sad time.

OTI:

Most of OTI's activities have continued apace. In March, OTI responded to a request for image information on the Constitution (III)-class exploratory cruiser. OTI is also preparing the next stage of chronological research for the addition of more material to the Trek Timeline. Coming up will be the "Picard" tie-in novels and "Lower Decks". Work also continues on the expansion of the Office's collection of starship silhouette graphics, for use in upcoming publications as needed. We are gradually closing in on the end of the classes in use by STARFLEET, and will then work on the best way to make the entire collection available for use. Also in the planning stages is a project to prepare a set of ship views, all at a consistent scale, for use by STARFLEET. A final idea under consideration are some tech-related PowerPoint presentations as something fun to share. That concept is still somewhat amorphous, but may tighten up with more consideration.

OSA - Schematic Artist:

I am sad to report that CAPT Gerhard Pretorius has resigned from the Office of Schematic Art. He realized that he has just got too much on his plate, and given his array of commitments, OSA is the area from which it seemed most reasonable for him to step away. I have, with understanding but sadness, accepted his resignation, but have left the door open for him to return at any point in the future, should he so choose. We continue to search for additional personnel to fill positions in this office.

One of two very important projects completed in March was *The Communique*¹ that was emailed to members on April 1. The poll in the CQ Mailchimp this time was designed to get feedback from the readers on their favorite part of the CQ. Because of the free app that we use, only one answer can be submitted. It will be interesting to see what part gets the most votes.

Mailchimp gurus Trisha Tunis and Melissa Ruth had to contact IS since the CQ test emails they were sending out were not getting through to the sfi.org addresses. They had to send the CQ Editor and I the tests through our personal gmail accounts so that we could do proofing while that issue was being worked out. This just started happening when IS switched servers. We believe this has been resolved. A Mailchimp to Region 3 members only to promote their Summit in June is in the works.

Producer Ryan O'Connor has been working on securing guests for the May 5 *SNN – The Briefing Room*, and the June 2 *STARFLEET News Now*. Another Producer, Dave Lyons, is being trained to handle the Streamyard work for *SNN-TBR*. Producer Bradley O'Connor has prepared the opening and closing graphics for that production. ST:DS9 actor Chase Masterson has just accepted an invitation to be a guest on the June 2 broadcast. A spreadsheet with available dates and times was prepared and sent to all ECAB members on March 30 for them to schedule a time to record their IC greeting. We have received only a few responses so far.

The Social Media Services team has increased by two. CMDR Ben Thomas was reassigned from another position to be Deputy SMS Director, and Jason Marks was added as a Moderator for Facebook and Discord. Ben has recently had back surgery so his assignment of specific duties was briefly postponed. The Pinterest Director reported that the March audience was 2.2k, down 5.8%. There is a total of 1,495 Followers. The most active Board was “Music Aboard Ship.”

Comms is very excited to welcome to the department the new Public Relations Director. New Database Development

In March, the board received a comprehensive demonstration showcasing member profiles, chapter profiles, our newly integrated MSR reporting tool, and the overall interface of the database. The feedback from the board was overwhelmingly positive.

To gather further insights, a Google form was distributed across our social media platforms to solicit input from those in leadership roles. We received a lot of responses and are using that feedback for the current sprint.

The next scheduled demo is now set for Sunday, April 28th, a slight adjustment from the initial date of the 21st due to a personal conflict faced by the lead developer. This upcoming demonstration will focus on refining the completed work based on board feedback, introducing roles/tasks/security measures, RSR's, and offering a preview of badges.

Looking ahead, we aim to conduct a demo for the entire fleet in late May or June, with the specific date to be determined. This will ensure comprehensive engagement and feedback from all membership.

SFI Servers Update

All sites on our servers are performing normally.

InfoServ Internal Help Desk:

Help Desk tickets continue to experience a delay assigned to the InfoServ team but are actioned on within 24 hours. We saw an influx of tickets due to the gmail block mentioned below. As of the time of this report, there is one ticket open which is a complex ticket, actively being worked on.

Email Issues and Forwards

Following the seamless migration of all our emails to the new server, an unexpected issue arose a few days later when our emails were blocked system-wide from reaching Gmail accounts. This prompted an urgent email audit, which revealed that an individual had been rapidly forwarding all their unread emails to their personal Gmail address. This activity triggered Gmail's spam detection algorithms, resulting in the block.

Although diagnosing this issue consumed significant time and caused inconvenience for volunteers using sfi.org email addresses, it underscored the importance of using organizational emails over personal ones. The matter has been promptly addressed, and measures have been implemented to prevent such occurrences in the future.

Regional and Chapter Websites

All SFI Regions are now eligible to receive a complimentary website hosted on SFI.org. To qualify, each Region must designate a webmaster responsible for overseeing website construction and management using the SFI WordPress multi-site platform.

In addition, SFI is now offering website hosting services to chapters and auxiliary units. Interested chapters can reach out to InfoServ directly for more information, while comprehensive packages are available on the QM site.
